**Daniel Morgan Water District Service Policy**  
Please read and sign below

All water furnished shall be on a metered basis. A separate water meter and water line shall be installed for each dwelling, unit, or business establishment served with water. Any variance from this policy will be considered a violation of the policy and is subject to disconnection.

All bills are due on the 12<sup>th</sup> day of each month. A 10% late fee will be added if not paid by the 12<sup>th</sup> day of each month. Non-payment within thirty (30) days from the due date will result in the water being shut off from the user's property. A \$75.00 Non-payment fee will be added for payments not received by the cutoff date.

Non-payment for sixty (60) days after the original due date will allow The District to remove the meter and cause forfeiture of initial tap fees.

Returned Checks will result in a \$45.00 fee.

By signing this application for water, the applicant agrees to pay all costs of collection of the applicant's unpaid bills. The Daniel Morgan Water District has the right pursuant to the South Carolina Setoff Debt Collection Act to collect any sum due and owed by the applicant through offset of the applicant's state income tax refund. If Daniel Morgan Water District chooses to pursue debts owed by the applicant through The Setoff Debt Collection Act, the applicant agrees to pay all fees and costs incurred through The Setoff process, including fees charged by The Department of Revenue, The Municipal Association of South Carolina, and/or The Daniel Morgan Water District. If Daniel Morgan Water District chooses to pursue debts in a manner other than setoff, the applicant agrees to pay the costs and fees associated with the selected manner as well.
