THE SERVICE POLICY OF DANIEL MORGAN WATER DISTRICT IS. ALL WATER FURNISHED SHALL BE ON A METERED BASIS. A SEPARATE WATER METER AND WATER LINE SHALL BE INSTALLED FOR EACH DWELLING UNIT OR BUSINESS ESTABLISHMENT SERVED WITH WATER. ANY VARIANCE FROM THIS POLICY WILL BE CONSIDERED A VIOLATION OF THE POLICY AND IS SUBJECT TO DISCONNECTION.

ALL BILLS ARE DUE ON THE 12TH OF EACH MONTH. 10% WILL BE ADDED IF NOT PAID BY 12TH OF MONTH. NON-PAYMENT WITHIN THIRTY DAYS FROM THE DUE DATE WILL RESULT IN THE WATER BEING SHUT OFF FROM THE USER'S PROPERTY. A \$75.00 NON -PAYMENT FEE WILL BE ADDED FOR PAYMENTS NOT RECEIVED BY CUT OFF DATE.

NON-PAYMENT FOR SIXTY DAYS AFTER ORIGINAL DUE DATE WILL ALLOW THE DISTRICT TO REMOVE THE METER AND CAUSE FORFEITURE OF INITIAL TAP FEES.

\$35.00 WILL BE CHARGED FOR ALL RETURNED CHECK.

BY SIGNING THIS APPLICATION FOR WATER, THE APPLICANT AGREES TO PAY ALL COSTS OF COLLECTION OF THE APPLICANT'S UNPAID BILLS. THE DANIEL MORGAN WATER DISTRICT HAS THE RIGHT PURSUANT TO THE SOUTH CAROLINA SETOFF DEBT COLLECTION ACT TO COLLECT ANY SUM DUE AND OWED BY THE APPLICANT THROUGH OFFSET OF THE APPLICANT'S STATE INCOME TAX REFUND. IF DANIEL MORGAN WATER DISTRICT CHOOSES TO PURSUE DEBTS OWED BY THE APPLICANT THROUGH THE SETOFF DEBT COLLECTION ACT, THE APPLICANT AGREES TO PAY ALL FEES AND COSTS INCURRED THROUGH THE SETOFF PROCESS, INCLUDING FEES CHARGED BY THE DEPARTMENT OF REVENUE, THE MUNICIPAL ASSOCIATION OF SOUTH CAROLINA, AND/OR THE DANIEL MORGAN WATER DISTRICT. IF DANIEL MORGAN WATER DISTRICT CHOOSES TO PURSUE DEBTS IN A MANNER OTHER THAN SETOFF, THE APPLICANT AGREES TO PAY THE COSTS AND FEES ASSOCIATED WITH THE SELECTED MANNER AS WELL.
